



Conclusions from the meeting of the Monitoring and Coordination Board of UPJŠ in Košice, held on September 28, 2020

1. It is required for faculties and university workplaces to monitor the state of the epidemiological situation and to update the data of the COVID form for the Ministry of Education, Youth and Sports. The contact person with whom they will communicate about the questionnaire and data is the vice-dean for education for each faculty. The university contact person is Mgr. Adriana Sabolová, chancellor of UPJŠ.
2. With effect **from September 29, 2020**, to carry out the teaching of lectures in the online distance form. Apply the full-time form in other forms of teaching according to the decision of the dean of the faculty. The Dean may decide on the implementation of teaching exclusively in the online distance form. In the case of full-time form, to follow the principles of hygiene and disinfection of premises, devices and equipment.
3. To strictly follow wearing of face-masks and hand disinfection in all interiors of the university, including accommodation and catering facilities.
4. We recommend for the Slovak students to temporarily leave the student dormitories of the university. It is recommended for the Slovak students to leave the student dormitories of the university, if their presence is not required in the educational activities and if they have their education fully ensured by online distance methods. Students from abroad are advised to remain in their Slovak residence until the development of the epidemiological situation is clarified and the date of change to contact teaching is determined. In case contact teaching is renewed, it is possible to expect complications associated with the return to Slovakia due to the measures taken by the Public Health Authority of the Slovak Republic.
5. There is a strict ban on visits by foreign persons in the premises of UPJŠ student dormitories, a ban on mutual visits of accommodated students in the rooms, mutual communication of accommodated persons is possible only on joined rooms. All social activities in the club premises or other premises of the ŠD are prohibited. The management of the SD is recommended to carry out ongoing inspections of compliance with the principles at the student dormitories in cooperation with student representatives.
6. The director of Student Dormitories and Canteens and the head of the canteen are instructed to specify particular measures to limit the number of diners in student canteens, to monitor the capacity and hygiene of movement in student canteen. It is forbidden to organize social events on the premises of student canteens.
7. In case of a possible COVID 19 infection or a possible risk of infection of a student, the student informs the study department of the faculty about this fact and at the same time by e-mail all teachers and students with whom he came into contact. If a student reports absence from class due to deteriorating health, such absence is justified and no medical certificate is required.

8. It is recommended to limit the contact of employees older than 65 years with students in full-time teaching as much as possible.

9. To measure the body temperature of students when participating in full-time educational activities. It is recommended to minimize the number of visitors in UPJŠ buildings.

10. Lifelong Learning Center's educational activities are interrupted, in special cases it is possible to carry out activities remotely.
