The conference summarises the scientific outputs of the VEGA grant project No. 1/0431/23 Competition for the interests of consumers and traders in the provision of digital content and digital services in the Digital Single Market, with an emphasis on legal and economic aspects.

The international scientific conference focuses on current legal and economic aspects of consumer access to digital content in the context of new European and national legislation. The focus is on the need for legal certainty for consumers, traders, and online service providers in the cross-border delivery of digital content. Interest is concentrated on issues of consumer protection in contractual obligations, including personal data protection, liability, and the enforceability of consumer's and trader's rights. Special attention is paid to intellectual property protection, particularly in the context of requirements for the legality and interoperability of digital products and services. Harmonized consumer legislation is expected to remove legislative barriers, which stimulates business in the single digital market with a positive impact on regional competitiveness and economic growth. The conference will present the scientific conclusions of the researchers of the VEGA project No. 1/0431/23 Competing interests of consumers and traders in the delivery of digital content and digital services in the Digital Single Market, with an emphasis on legal and economic aspects.

The conference will be held in a hybrid format (in person and via MS Teams).

The working languages of the conference are Slovak, Czech, and English.

In case of active participation, it is necessary to send an abstract of the contribution together with the registration for the conference. The organizers reserve the right to select contributions that will be included in the conference program.
