

## General Data Protection Regulation

**Information obligation when obtaining personal data of the persons concerned under Art. 13 Regulations of the European Parliament and the Council of the EU No. 2016/679 of April 27, 2016, on the protection of natural persons with regards to the processing of personal data and on the free movement of such data, repealing Directive 95/46/EC (General Data Protection Regulation), known as GDPR.**

Pavol Jozef Šafárik University in Košice (hereinafter UPJŠ“), Šrobárova 2, 041 80 Košice, Slovenská republika, TIN: 00 397 768 is an operator that processes personal data. The operator has the status of a public university under Law Act No. 131/2002 Coll. on Higher Education Institutions and on the Amendment to Certain Law Acts as amended. UPJŠ is considered the operator even in cases where your data is processed by UPJŠ Faculties and/or independently managed constituents of UPJŠ

Legal terms for processing your personal data: the operator is authorized to process personal data to the extent necessary for the specified purpose based on Art. 6 points 1 letter b) GDPR. The provision of personal data serves to ensure the organization and realization of the event. For administration purposes it is essential that you provide us with the personal data required in the application, otherwise you will not be able to participate in the event.

Retention period: the operator archives and stores the personal data of the person concerned for the period determined by applicable legal regulations and the operator's internal regulations.

There is no automated decision-making at the UPJŠ, including the profiling referred to in Art. 22 par. 1 to 4 GDPR.

As a data subject, you have the rights established by the GDPR when processing your personal data. You can claim them from our person in charge through a request, either electronically or in writing: [zodpovedna-osoba@upjs.sk](mailto:zodpovedna-osoba@upjs.sk)

Your rights as a data subject:

- 1) The right to access personal data according to Article 15 of the GDPR that we process about you. This right includes the right to confirmation as to whether we are processing personal data about you, the right to access that data, and the right to obtain a copy of the personal data we are processing about you, if technically feasible;
- 2) The right to correct and supplement personal data according to Article 16 of the GDPR, if we process incorrect or incomplete personal data about you;
- 3) The right to erase your personal data according to Article 17 of the GDPR;
- 4) The right to restriction of the processing of personal data according to Article 18 of the GDPR
- 5) The right to data transferability according to Article 20 of the GDPR;
- 6) As a data subject, you also have the right to file a complaint with the supervisory authority, which is the Personal Data Protection Office of the Slovak Republic under § 100 of the Personal Data Protection Act
