



Admission procedure for the academic year 2026/2027
for the study programme
British and American Studies
(bachelor degree, full-time and part-time forms)

Deadline for submission of applications: by 31 March 2026
(e-application of the Faculty of Arts of UPJŠ will be activated at the beginning of January 2026)

Each application is for one study programme only.

After submission of e-application, the candidates are not required to send a hard copy.

The candidates without a birth registration number (specific symbol) are required to contact the Study Affairs Office before making the payment.

The fee for the coverage of the material needs of the admission procedure at the Faculty of Arts of UPJŠ in Košice shall be refunded to the candidates only in the case the study programme is not opened due to insufficient number of candidates meeting the admission conditions only.

The Faculty of Arts of UPJŠ reserves the right to exclude the application from the admission procedure in the case of non-payment of the fee.

Standard duration of study:

Full-time study, Part-time study: 3 years

Basic admission conditions

1. A basic precondition for admission of the candidate to the university is **obtaining full secondary or full secondary vocational education**. A candidate that cannot prove meeting of basic admission conditions may be admitted for the study conditionally with a duty to prove meeting of the basic admission conditions not later than on the date of enrolment for the study. The right of the candidate that was admitted for the study conditionally shall cease to exist if the candidate fails to prove meeting of the basic admission conditions on the date scheduled for enrolment at the latest.
2. Each candidate must pass the **General Academic Prerequisites test** which is provided by the company **www.scio.cz, s.r.o.** (www.scio.sk)
 - 2.1. The GAP tests can be taken in several cities in Slovakia and on several dates during the academic year 2024/25. For the purposes of the admission procedure, the best result of the test taken **by 25 April 2026 for fulltime students** and **by 23 May 2026 for the par-time students** at the latest will always be counted towards the applicant's admission.  - 2.2. The result of the GAP test is shown in percentile, which is converted into points: 1 percentile = 1 point. The maximum a candidate can obtain for this criterion is 100 points.
 - 2.3. The results of the test are submitted to the Faculty exclusively by Scio, the company awarded the contract for the implementation of the tests. Candidates do not submit their results to the Faculty. Each candidate must give his/her consent to the company awarded the contract for implementation of GAP tests and to give it the consent to submit the results (candidates will do so within the application for GAP).
 - 2.4. The results of the Czech version of the GAP test will be recognised as equal to the Slovak version.
3. Candidates are required to prove their knowledge of the English language by one of the following documents not older than 2 years:
 - 3.1. SCIO English Language;
 - 3.2. TOEFL ibt certificate above 95 pts;
 - 3.3. IELTS certificate above 7 pts;
 - 3.4. Cambridge CAE above 200 pts;
 - 3.5. General State English Language Examination at C1 level;
 - 3.6. 1st, 2nd and 3rd place at the Regional round of the English Language Olympiad or participation in the national or international round of this competition
 - 3.7. Matriculation exam in the English language at level C1 or proof of an equivalent matriculation exam in the English language taken abroad.

Further admission conditions

1. The application form may be submitted electronically (preferred method of submission) or the application form recommended by the Ministry of Education, Science, Research and Sports of the Slovak Republic for the academic year 2026/2027 may be filled in.
2. Each candidate must upload the school-leaving certificate in pdf format to the e-application available on the Faculty website no later than on the enrolment date. The candidates who passed school-leaving examination before 2026 will upload their school-leaving certificates in pdf format within submitting the e-application by the end of March 2026.
3. If a student, due to objective reasons, is unable to provide a school-leaving certificate, he/she must submit a written explanation (by email), specifying the reasons and the date of delivery.
4. The candidates who studied at a secondary school abroad must deliver the Decision on recognition of equivalence of a document of education, or the Certificate of equivalence of a document of education issued by a foreign school, i.e. "*nostrification*" of school-leaving certificate (in pdf format in the e-application form).
5. Each candidate will upload the certificates or other relevant documents in pdf format in the e-application within submitting the application.
6. Each candidate will upload the proof of payment of the fee for the coverage of material needs of admission procedure in pdf format in the e-application by the end of March 2026.

Information for candidates from abroad

The condition for admission of international students for study is proving a necessary qualification in the same manner as in the case of candidates being the citizens of the Slovak Republic.

The candidates from abroad and Slovak citizens taking a school-leaving examination abroad are obliged to submit a document proving equivalence of their secondary study to the Student's Affairs Office.

In these cases, it is not necessary to apply to the Regional School Administration Office in Košice for recognition of the educational document.

Applicants for study will find their country, the name of the educational document they hold (certificate/diploma), download the relevant equivalence clause, print it out, and submit it together with a certified and translated document certifying completion of education (translated by a Slovak court translator and certified by a Slovak notary) to the faculty's study department.

2. Procedure for the recognition of educational documents based on an application (application for nostrification):

For other countries outside the EU and countries with which the Slovak Republic has concluded an international agreement, but whose type of educational document does not have a clause, the application for recognition of educational documents shall continue to be submitted to the relevant regional school administration office, which shall then issue a decision within the statutory period after assessing the application.

Admission procedure rules

1. **The final ranking of candidates for a particular study programme depends on the total number of points obtained.**
2. The Dean of the Faculty at the meeting of the dean's admission committee decides on admission of candidates who have demonstrated the highest level of abilities to study in the chosen study programme only according to the final ranking of candidates. In the appeal procedure, only those appeals will be dealt with which are justified by a violation of these admission procedure rules or by a violation of Act No. 131/2002 Coll. on Higher Education.
3. The Dean of the Faculty has the right to decide to admit for the study also other candidates in the final ranking, according to the results of admission procedure for individual study programmes.
4. The Dean of the Faculty has the right not to open a study programme for which a sufficient number of candidates has not applied..

Other information

1. The candidates will be sent the information on acceptance of their application electronically to the email address they specified in the application, by the end of April 2026 (full-time students) and by end of June part-time students at the latest.
2. The results of the admission procedure will be published on the Internet by the end of May 2026 (full-time students) and by the end of June 2026 (part-time students) at the latest.
3. The decision on admission or non-admission for the study will be sent to the candidates in writing. A request for review of the decision of the dean on non-admission for the study may be filed with the Rector of UPJŠ in Košice under Section 58(6) of Act No. 131/2002 on Higher Education.
