

**Clerkship of UPJS MF students in
the Academic Year 2022/2023
Study programme: Dental Medicine**

1. **A student of the study programme of Dental Medicine can perform a professional clerkship at the L. Pasteur University Hospital in Košice (UNLP) and at private workplaces***
2. **A student of the 2nd year of study** performs the clerkship according to the group schedule during the summer of the academic year 2022/2023 at the 1st Department of Stomatology (I. SK), the Department of Stomatology and Maxillofacial Surgery (KSaMCH) and Košice Academy, Bačíkova 7, in two periods:

3.7.2023 – 14.07.2023

17.07.2023 – 28.07.2023

Those students are **not** requested to submit “the Request to take the clerkship in the academic year 2022/2023”. The students' enrolment for the clerkship will take place at the Secretary Offices of the Dental Departments **until 19.05.2023.**

A student of the 3rd and 5th year of the study programme of Dental Medicine wishing to perform the clerkship **in a private medical facility in Slovakia**, fills in and prints the "[Agreement on the provision of professional clerkship](#) / [Zmluva o zabezpečení odbornej praxe](#)" and, after it is confirmed by the private medical facility, is to be sent by student electronically to zuzana.salociova@upjs.sk (Professional Clerkship 2) or beata.moskova@upjs.sk (Professional Clerkship 3). After the contract is signed by the Dean/Vice-Dean of the Faculty, the Study Department will send the agreement electronically back upon to the student's request.

A student performing the clerkship at the UNLP Dental Departments will apply for the clerkship by the form "[Request to take the clerkship in the year 2022/2023](#)": which will be scanned and send electronically to the study referees by e-mail till **19.05.2023 at the latest** as follows:
