# Call for applications for short term Erasmus+ BIP student mobility – STUDY for the academic year 2023/2024

Department for International Relations at the Faculty of Medicine, UPJŠ would like to inform you about the possibility of applying for Erasmus + **BIP student mobility – STUDY** in the academic year 2023/2024.

Implementation period: until 31.7.2024

**For whom:** all duly enrolled full-time and part-time students from the 1st year can travel. The target group is determined by the organizers of a particular BIP. Only those students for whom a specific BIP is organized and who are nominated by the sending institution can attend a BIP mobility.

Is this type of mobility available for recent graduates?: No

**Place of mobility:** It is possible to travel only to the university/place where a particular BIP is organized.

**Duration of mobility:** 5 to 30 days of physical mobility + mandatory virtual element, the duration of mobility is determined by the BIP organizers.

**Financing**: Without limitation, the total length of mobility is financed.

## **Compulsory documents:**

- application form here
- curriculum vitae
- photocopy of a certificate of proficiency in a foreign language (except native speakers)

#### Optional documents (provide proof of membership by written confirmation):

- SSW,
- active member of the Association of Medical Students in Kosice,
- extracurricular activities associated with the study

**The selection committee will assess**: student academic results, foreign language knowledge, extracurricular activities associated with the study, the information contained in the application form.

**The results** of the selection procedure will be published in AIS within 10 days from the end of the given phase of the call.

**Obligations:** it is necessary to obtain at least **3 ECTS credits** during the mobility.

**Recognition:** The earned credits will be recognized in full for the student upon return. After the mobility, **it is necessary to apply for the recognition of credits** according to the procedure at the individual faculties. For more information about criteria and procedures, contact your coordinator.

#### **Grants:**

Participants of a short-term mobility (5-30 days) are entitled to individual support for physical mobility days, including travel days, regardless of destination country:

# Anything extra?

- Mobility participants with fewer opportunities are entitled to a one-time contribution above the basic rate in the amount of €100 for physical mobility lasting 5-14 days.
- Students can apply for the so-called "green travel" contribution. This is a one-time contribution of **EUR 50** in addition to the regular grant if the student uses: train, bus, shared car, bicycle as a mode of transportation for his/her trip to and/or from mobility.
- Participants with fewer opportunities can be granted support for travel costs. Travel expenses are covered by a special scale of fixed amounts according to distance bands valid for the entire program:

Travel distance	Standard travel	Green travel
From 10 to 99 km:	23 EUR per participant	
From 100 to 499 km	180 EUR per participant	210 EUR per participant
From 500 to 1 999 km:	275 EUR per participant	320 EUR per participant
From 2 000 to 2 999 km:	360 EUR per participant	410 EUR per participant
From 3 000 to 3 999 km:	530 EUR per participant	610 EUR per participant
From 4 000 to 7 999 km:	820 EUR per participant	
8 000 km or more:	1 500 EUR per participant	

• Other participants are not entitled to support for travel costs.
