

Requirements for completion

Subject: Pathological anatomy 2

Year: Third year of study, ST

Study programme: General Medicine

0. For registration of subject (prerequisite for registration) is necessary to successfully complete practical lessons/seminars of the subject Pathological anatomy 1.

I. For successful completion/recognition of the subject (prerequisite for subject completion) and earning the credits for the subject, the following is necessary:

Successful completion of practical lessons/seminars

Successful completion of two written revision tests

Attendance on lectures

Successful completion of the subject Pathological anatomy 1

II. For successful completion of the practical lessons/seminars is required:

- Mandatory 100% participation in practical lessons. Theoretical preparation for the lessons and methodical mastering of practical tasks.
- According to the Study Rules of Procedure at UPJŠ in Košice, Faculty of Medicine, Part II, Art. 12, Paragraph 8, non-participation in practical lessons must be justified.
- In the case of excused absence from practical lesson, the student is required to compensate practical lesson in the form of a seminar work based on the teacher's instructions. During the semester, it is possible to compensate a maximum of three practical lessons.
- Successful completion of the colloquium (practical part) at the end of semester.

III. For successful completion of two written revision tests is required:

- To get at least 60% (average) from both written revision tests.
- The date of each of the two written revision tests is scheduled in advance.
- Participation in both revision tests is mandatory. In the case of unexcused absence from the revision tests, a student cannot take part in the retake credit test, in case of excused absence from the revision tests, the student will have the opportunity to attend alternative date of revision test in week 14th. Absence has to be excused not later than 3 working day after regular term.
- If the student does not get the required evaluation from the written revision tests (or has excused absence from the revision tests), the student will have the opportunity to write two retake credit tests, which are in the scope of the topics from the entire semester (topic of weeks 1-13). And the dates of which will be determined at the end of the summer term and one date of which is set in the 14th week of the semester and the 2nd date will be set at the end of the summer semester in the summer examination period of the academic year. It is up to the student whether he/she will take advantage of both scheduled dates.

- The tests are evaluated based on the number of points (%) achieved according to the Study Rules of Procedure at UPJŠ in Košice, Faculty of Medicine, Part II, Art. 13, Paragraph 4:
 - results 91 - 100 % are evaluated „completed – A- excellent“,
 - results 84 - 90 % are evaluated „completed - B – very good“,
 - results 75 – 83 % are evaluated „completed - C - good“,
 - results 68 - 74 % are evaluated „completed - D - satisfactory“,
 - results 60 - 67 % are evaluated „completed - E - sufficient“.

IV. Attendance on lectures:

- Attendance at lectures is a compulsory part of fulfilling the study requirements of the course Pathological Anatomy 2. Fulfilment of this requirement requires a minimum of 50% attendance at lectures, which corresponds to attendance at 12 lectures, including two credit tests.
- For third-year students, attendance at lectures is mandatory in the full extent of the prescribed minimum attendance and without the possibility of substitution.
- For students of other years who are enrolled in the course and who in advance, no later than by the end of the second week of the semester, credibly demonstrate a schedule conflict between lectures and other compulsory teaching activities (lectures or practical classes), a substitution of lecture attendance in the form of seminar papers may be permitted at the discretion of the instructor.
- The student is obliged to notify the secretary Eva Filipová, without delay, who will ensure the student's registration and inform them of the scope, number, and deadlines for submission of the seminar papers.
- Attendance at lectures is recorded through electronic registration of the student's arrival and departure. Attendance is considered fulfilled if the registration is completed within a time window of no more than 15 minutes before the start or no more than 15 minutes after the end of the lecture.

V. For successful completion of colloquium is required:

- Correctly recognize and describe at least 2 diagnoses out of 3 that the student has chosen.
- Students choose 3 random histological preparations (slides) from among the 102 they studied during the practical lessons.
- The student's participation in the colloquium during practical lessons is mandatory. In case of unexcused non-participation in the colloquium, the student cannot participate in the retake colloquium, in case of excused non-participation in the colloquium, the student will only participate in the retake colloquium.
- If the student does not get the required evaluation, the student will have the option of the two retake colloquiums, the dates of which will be determined at the end of the summer term. It is up to the student whether he/she will take

advantage of both scheduled dates.

- VI. Before admitting the student to the final exam, the student has to receive an assessment in the range of A-E in the subject Pathological Anatomy 1.**
- VII. If one of the conditions is not met, the student will not proceed to the final exam of the subject**
- VIII. The final exam in pathology takes place during the examination period of the summer term.**
