



## Clerkship of UPJS MF students in the Academic Year 2025/2026 Study programme: Dental Medicine

1. Students in the study programme *Dental Medicine* can perform a professional clerkship at the L. Pasteur University Hospital in Košice (UNLP) and at the private workplaces.

2. Students in the **1<sup>st</sup> evidence year of the 5<sup>th</sup> year programme**, and **2<sup>nd</sup> evidence year of the 6<sup>th</sup> year programme** perform the clerkship according to the group schedule during the summer term of the academic year 2025/2026 at the 1st Department of Stomatology, the Department of Stomatology and Maxillofacial Surgery, and at Košice Academy, Bačíkova 7, in two periods:

29.06.2026 – 10.07.2026

13.07.2026 – 24.07.2026

Those students are **not** requested to submit the request to take the clerkship. The students' enrolment for the clerkship will take place at the Secretary Offices of the Dental Departments by **30.04.2026**, at the latest.

3. Students in the **3<sup>rd</sup>** and **5<sup>th</sup> evidence year**:

a.) wishing to perform the clerkship at **the UNLP Dental Departments** will apply for the clerkship by the form "[Žiadosť na vykonanie odbornej praxe](#)". The scanned copies or hard copies (originals) must be submitted to the study referees by 30.04.2026 at the latest.

b) wishing to perform the clerkship in **a private medical facility in Slovakia**, fill in and print the "Agreement on the provision of professional clerkship" "[Downloads/zmluva-o-zabezpeceni-odbornej-praxe.doc%20\(4\).docx](#)"

The Agreement, confirmed by the private medical facility, is necessary to submit in the form of hard copies or sent electronically to the study referees. After the Agreement is signed by the Dean/Vice-Dean of the Faculty, it is possible to collect personally by the student or receive it electronically back upon to the student's request.
