## Erasmus+ mobility of students KA131 in programme countries for study or traineeship - 1<sup>st</sup> call round for the academic year 2024/2025

### **Mobility period:**

**Long-term study mobility:** winter and summer semesters of the academic year 2024/2025.

**Long-term traineeships:** from **1.6.2024** till **30.6.2025**.

### **Types of learning mobility:**

- Long-term study stay with a minimum duration of 2 months (for all levels of study)
- long-term study stay combined with an internship with a minimum duration of 2 months (for all levels of study)

### **Types of traineeship mobility:**

- long-term internship with a minimum duration of 2 months (for all levels of study)
- long-term internship to improve digital skills with a minimum duration of 2 months (for all levels of study)
- long-term internship for recent graduates with a minimum duration of 2 months, while the internship can be professional or focused on improving digital skills (for graduates of Bc., MSc., PhD. studies), implemented within 12 months of graduation from P. J. Šafárik University in Košice.

### **Important dates and how to apply:**

**Long-term mobility:** for long-term mobility - study/internship it is necessary to apply at the individual departments/institutes until **21.3.2024** by contacting the ERASMUS+ coordinator and also by using the [form](#).

### **General rules for the implementation of mobilities:**

- The rules of the call follows the rules of the [Directive No.1/2020](#), which establishes the procedure for the administration of the Erasmus+ programme at the Pavol Jozef Šafárik University in Košice and its units.
- The processing of applications, checking of the documents and information submitted and evaluation within the faculties **is the responsibility of the faculties**.
- A committee composed of the Institute Coordinators and the Vice Dean for External Relations will select from among the applicants those who meet the criteria listed below,

compile a list of relevant applicants and send it to the Department of International Relations of P. J. Šafárik University. **The final selection of the applicants is the responsibility of the International Relations Department of P. J. Šafárik University.**

**Criteria for the selection of applicants from the Faculty of Science of P. J. Šafárik University in Košice:**

- **Completed all courses enrolled in the previous academic year.** The data on the achieved study results are collected by the Faculty ERASMUS+ coordinator (vice-dean) or the departmental coordinators through the study department of the Faculty of Science of P. J. Šafárik University, it is not provided by the mobility applicants;
- In case of the **mobility internship**, provide evidence (to be sent to the institutional coordinator) of a preliminary e-mail acceptance for the internship from the host institution. For internal PhD students, the supervisor's approval must be provided to the institutional coordinator by e-mail;
- **Active knowledge of the required foreign language(s)/language(s)** as required by the partner university/institution abroad. Not required for partner universities in the Czech Republic. Method of demonstrating language proficiency to be determined by the institutional coordinators (e.g. interview, copy of certificate, copy of school leaving certificate).
- **Additional criteria may be set** by individual faculty institutes and will be communicated to the candidate by the Institute [Coordinators](#).

**Mobility under this call can take place in the following countries:**

<b>Non-EU programme countries</b>	North Macedonia, Serbia, Iceland, Liechtenstein, Norway, Turkey

- Student mobility for the purpose of **study is governed by bilateral agreements**, which contain the exact number of student mobilities for a given field, with the exact duration of their stay. The host university must be a higher education institution of an Erasmus+ country with an ECHE charter (European Charter for Higher Education). For more information on bilateral agreements for individual disciplines, please contact the faculty (departmental, institutional) Erasmus coordinators as well as the staff of the International Relations Office of the Rectorate of P. J. Šafárik University.
- Situations which are primarily linked to the epidemiological situation and which constitute an exception to the rules of this call are decided by the Erasmus Commission (e.g. postponement of the original mobility date to a period which no longer falls within the implementation period of this call).


