SPIELBERG, S.:

The Amistad

Historical drama based on the notable mutiny in 1839 by newly captured Mende slaves who took control of the ship La Amistad off the coast of Cuba and the international legal battle that followed their capture by a U. S. revenue cutter. It became a United States Supreme Court case of 1841 (40 U. S. 518; January 1841). Opinion by Justice Joseph Story.

Lincoln

The final four months of Lincoln's life, focusing on the President's efforts in January 1865 to have the Thirteenth Amendment to the United States Constitution passed by the United States House of Representatives.

LUMET, S.:

Twelve Angry Men

Eleven jurors are convinced that the defendant is guilty of murder. The twelfth has no doubt of his innocence. How can this man steer the others toward the same conclusion? It is a case of seemingly overwhelming evidence against a teenager accused of killing his father.

KRAMER, S.:

Inherit the Wind

The controversial subject of evolution versus creation causes two polar opposites to engage in one explosive battle of beliefs. Attorney Henry Drummond faces off fundamentalist leader Matthew Harrison Brady in a small Tennessee town where a teacher has been brought to trial for teaching Darwinism.

SIMONEAU, Y.:

Nuremberg (Trial)

Preparation of a war crime tribunal against Hermann Göring and the surviving Nazi leadership. Cross-examinations of the defendants.
